This is an Appeal under section 68 of the Punjab Cooperative Societies Act, 1961 against the order dated 24.5.2006 placing the Managing Committee of the United Cooperative House Building Society Ltd. Mohali under suspension .

Opening the arguments , counsel for the petitioner argued that

committee has been suspended hereby three months after the election and in this limited period there can not be consistent default as provided under the Act , for suspension of committee . Also direction by Assistant Registrar, Cooperative

Societies, Mohali that new member should be added with his permissions is against the bye law of the society. Allegation like non production of record to Audit & Managing Committee members being supporters of president are illogical. Therefore , he pleaded that order dated 24.5.06 of Deputy Registrar, Cooperative Societies be set aside .

Assistant Registrar, Cooperative Societies, Mohali has filed reply on behalf of the D.R.C.S. Ropar and A.R.C.S. Mohali. He has pleaded that major reason of complaints is enrollment of members and consequent financial

irregularities . Also possession of flats have been given illegally and no action has been taken against the then committee members and record is not being produced before the Audit, Committee has been suspended only to streamline its working and take action against guilty committee members. Therefore, he pleaded that order of D.R.C.S. dated 24.5.06 is justified and appeal be dismissed.

In view of the reply of A.R.C.S. Mohali, show cause notice has been issued and reply by the committee is awaited . Therefore, petitioner is directed to file their reply to the show cause notice within 15 days , with a further direction to D.R.C.S. Ropar to decide the matter in another 15 days. Consequently their being nothing left in this appeal to be decided, is dismissed.
